I) Increase In Intake:

The Governing Council discussed the approval of increase in Intake by AICTE and also the infrastructure to be added to the concerned departments. The additions in the civil

department is one division i.e., 60 seats from the academic year 2014-15. For this, additional infrastructure has already been received and the faculty have been recruited.

II) New PG (M.Tech) Programs:

a) Mechanical Department (Machine Design) with 18 intake:

At PG Level, 18 seats have been approved for the academic year 2014-15.

The Laboratory infrastructure is received and being commissioned. One qualified faculty at Doctorate level and others with M.Tech have been recruited.

b)Civil Department (Strucutral Engineering) with 18 intake:

Civil Engineering department has received PG course approval for Structural Engineering for 18 seats. The related Lab Equipment has been procured and being commissioned. One qualified faculty at Doctorate level and others with M.Tech have been recruited.

III) Faculty Recruitment:

The vacancies in the various departments were filled in two phases. Interviews were conducted (One on 16.06.2014 and the other on 24.05.2014).

IV) FDP Programs:

- 1. One FDP is schedule for 26th & 27th June 2014 on teaching skills,
- 2. One FDP is schedule for 3rd & 4th July 2014 on EDP

V) Placements:

The total recruitment of our students in various placement activities till today has reached to 327. Still several placement agencies have shown their willingness to visit our college for the placement.

VI) Applied for NAAC:

The Letter Of Intent (LOI) for application to NAAC has been prepared and will be sent this week.

VII) Applied for MODROBS:

The three departments namely CSE, ECE & EEE have applied for modernization of the Laboratory. The report of approval is awaited from AICTE.

VIII) Permanent Affiliation from JNTUH:

The college has received permanent affiliation for five years for the period 2014-15 to 2018-19, on the basis of inspection by Fact Finding Committee (FFC) from JNTUH.

IX) Feedback:

Periodic feedbacks are collected from various stake holders as per the practice and analyzed summary report along with action taken were discussed. It is decided to take online feedback periodically from student about the teaching learning process.

I) Increase In Intake:

II) New PG (M.Tech) Programs:

a) Mechanical Department (Machine Design) with 18 intake:

At PG Level, 18 seats have been approved for the academic year 2014-15.

The Laboratory infrastructure is received and being commissioned. One qualified faculty at Doctorate level and others with M.Tech have been recruited.

b)Civil Department (Strucutral Engineering) with 18 intake:

V) Placements:

The total recruitment of our students in various placement activities till today has reached to 327. Still several placement agencies have shown their willingness to visit our college for the placement.

VI) Applied for NAAC:

The Letter Of Intent (LOI) for application to NAAC has been prepared and will be sent this week.

VII) Applied for MODROBS:

The three departments namely CSE, ECE & EEE have applied for modernization of the Laboratory. The report of approval is awaited from AICTE.

VIII) Permanent Affiliation from JNTUH:

The college has received permanent affiliation for five years for the period 2014-15 to 2018-19, on the basis of inspection by Fact Finding Committee (FFC) from JNTUH.

IX) Feedback:

Periodic feedbacks are collected from various stake holders as per the practice and analyzed summary report along with action taken were discussed. It is decided to take online feedback periodically from student about the teaching learning process.

The following decisions are taken:

- The feedback from Alumni will be analyzed and appropriate action will be taken.
- Extra Curricular activities should be conducted on regular basis.
- The students are encouraged to undergo various activities for self learning.

XIV) Budget:

Budget utilization with respect to planning is discussed about advertisement, annual day, insurance, miscellaneous, maintenance of physical & academic maintenance, infrastructure, budget for updation and up gradation of computing facility, salaries, books and e-resources in the library etc,. Also discussed about the budget planning and sources of fund for the upcoming financial year.

XV) Skill Improvement:

Campus Ready Training (CRT), Career Counseling for all the final year students are conducted. Yoga and Meditation classes are offered to all the students. Vocational Education Training (VET) programmes are initiated for the students. To improve the skill set of student and make them skillful and employable various activities are conducted such as competitive exams, career counseling, guidance for entrepreneurship, soft skill training, remedial coaching, bridge course etc, list of the companies visited and number of student placed are also discussed.
